1. ACCOUNTING POLICIES

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards.

1.2 Going concern

The company has received a loan from Vastani Company SA which has been subordinated and deferred until the company has an operational surplus. The company has received an undertaking from Henning Gold Mines Inc. that the company will be supported for a period of not less than 12 months from the date of signing the accounts. The directors are therefore of the opinion that it is appropriate to adopt the going concern basis.

1.3 Investments

Investments held as fixed assets are shown at cost less provision for impairment.

1.4 Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated into euros at rates of exchange ruling at the balance sheet date.

Transactions in foreign currencies are translated into euros at the rate ruling on the date of the transaction.
